1. Purpose and Scope of Collection and Processing of Personal Data

The Firm may collect, process and use the following personal data of clients or potential clients for the purpose of providing legal consultation and related services (including providing the latest legal news and event notifications), and for legal compliance, maintaining information security, and other management purposes (hereinafter referred to as “Specific Purposes”): name, title, company or organization name, email, contact phone number, address, and other necessary personal data required for handling entrusted matters.

2. Storage and Transmission of Personal Data

Personal data collected for the aforementioned Specific Purposes will be stored by the Firm for a reasonable period to achieve these purposes. The Firm will protect personal data from abuse, interference, and unauthorized loss, access, modification, or disclosure using appropriate encryption and confidentiality measures, and will comply with all applicable data protection laws and professional confidentiality and ethical obligations (hereinafter referred to as “Security Measures”).

In cases where the Firm is mandated by clients or required by law to transmit relevant personal data to specific recipients and regions (including but not limited to third parties mandated by the Firm to process personal data), the Firm will transmit it using appropriate Security Measures. If necessary, the Firm will require the data recipient to take measures no less stringent than the Firm's Security Measures to protect the received personal data through contractual clauses.

Despite the Security Measures taken by the Firm, data transmitted via the internet or stored in databases or other methods cannot be guaranteed to be 100% secure. Therefore, while the Firm will strive to protect your personal data with appropriate Security Measures, we cannot and do not guarantee or warrant the security of any personal data. We will not be and are not liable for any disclosure or leakage of personal data due to transmission errors, networks that are beyond our control or unauthorized actions by third parties.

3. Your Rights

As an owner of the personal data, you have the right to choose whether or not to provide your personal data to the Firm. If you choose not to provide it, it may affect our ability to provide you with legal consultations or other services. After providing your personal data, you may contact us in writing to request access, review, supplementation, correction, cessation of collection, processing, utilization, or deletion of your personal data, or to request a copy of your personal data. If you wish to exercise any of these rights, please submit a written request to the Firm along with relevant identification documents. The Firm will respond in writing within fifteen days of receiving your written request. When necessary, we may notify you of an extension to respond within thirty days.
